



SCHHA and AHHL are the 2 largest and most representative policy voices on issues impacting trust lands as defined under the Hawaiian Homes Commission Act of 1920 (HHCA). SCHHA founded in 1987, and AHHL founded in 2008 represent the interests of 10,000 trust land lessees and 28,000 on the waitlist. Each are registered as federally defined homestead associations under 43 CFR Part 47/48 with the Department of Interior.
